BASIC TERMS AND CONDITIONS SUMMARY: 1. All Members, Players or Guests who attend the Academy premises, whether it be socially or to use the equipment, does so at their own risk. 2. All persons involved are to conduct themselves in a respectful and sporting manner on and off the premises. 3. The upkeep of the premises and equipment is the responsibility of all who uses it. 4. Any damage to any part of the premises or the contents will be repaired or replaced by the person/persons who caused it. 5. The Academy membership is open to all persons, (being referred by a current member or personally recommended by another well known and trusted party is desired). 6. The Academy reserves the right to refuse membership or guest access as it sees fit. 7. All memberships are for a period of 6 months and all persons registered are committed to that time period. 8. All registered members must submit their subs at the agreed time so to cover all the Academy overheads and costs. 9. Membership subs are non-refundable and must be paid on time and in advance by each member. 10. A minimum 3 month notice must be given by any member who is considering cancelling their membership before the 6 month time period has been completed. Special circumstances for early membership termination may be considered but cannot be guaranteed. 11. Failure to comply with any of the Rules, Terms and Conditions or Constitution of the Academy may result in the immediate suspension and/or termination of the person/persons membership, depending on the severity of the situation. A fine and/or a ban may also apply in some circumstances. 12. The Rules, Terms and Conditions and Constitution of the Academy are to be enforced by all members/players. They are put in place for the purpose of the smooth running and safety of the setup and to ensure that the best interests of the Academy and its members are first priority. **NOTE:** Any of the Rules, Terms and Conditions can be modified or added to when and if necessary and without notice. Please refer to the members area of the website for further details or for any changes that may be made since this document was last printed. By completing and signing this form you agree to, and accept fully, all Rules, Terms and Conditions of the Academy membership when joining.

Subs Tariffs and Access Options.

Note: you cannot change between tariffs within a term or 6 month period!

Note: with all memberships there is a once-off sign up fee of 60 Euro which is due with your completed membership form!



OPTION 1

(Membership) **Weekly Bank Standing Order Transfer: 20 Euro per week**

This must come through every week for the membership to remain active!

This fee entitles the person to access the venue and utilise the equipment.



OPTION 2

(Membership) **Monthly Bank Standing Order Transfer: 87 Euro per month**

Transfer must be received before the 1st of the month in question.

(For example: for Junes subs, set your transfer to send between May 25th & 30th, and so on)



OPTION 3

(Membership) **Cash Payments: 260 Euro per quarter (only available at the start of each quarter!)**

If you don't have a bank account or don't wish to make use of the other options above then you will be required to give 3 months subs fees in advance along with the sign-up fee. (€260 subs + €60 sign-up fee)

The quarterly option is only available at the start of each quarter. (1-June, 1-Sept, 1-Dec, 1-Mar each year)



OPTION 4

(Membership) **One Yearly Payment: €695 Euro (only available in the month of June each year)**

This option is for a 1 year membership with no weekly or monthly subs fees.

It runs from June 1st on the year in question to May 31st the following year.

The fee must be paid up front and cleared in the month of June to avail, it cannot be paid in instalments.

No sign up fee will apply with this option!



OPTION 5

(Non-Membership) **Booked Hourly Visits: 10 Euro per hour**

A maximum of 2 people per visit per table will be allowed.

This will be strictly on a booking only basis.

Each 2 visitors will be considered an entirely new visit and hourly fee.

Anyone not holding an active membership will be required to pay a visit fee based on the times they book / use.



OPTION 6

(Non-Membership) **Booked Session Visits: 20 Euro for 3 hours (max 2 persons per table)**

This option is only available to visitors coming in to practice or play against a full member!

Fee has to be paid on the day of visiting or in advance before a person can enter the facility.

The maximum booking for this rate is 3 hours. Pending availability, the table can be booked per hour after that.

(A per hour fee of 10 Euro will apply after that and again is payable in advance of each hour!)

Note: Visits that go over the booked time;

If it goes 10 minutes into the next hour then the hour will be charged for!

Anyone not holding an active membership will be required to pay a visit fee based on the times they book / use.

It makes no difference if someone is coming in for 10 minutes or intends to stay longer, the fee still applies.



OPTION 7

(Non-Membership) **Month-by-Month Visits: 120 Euro for 1 month access**

This is usually for someone who wants to try out the facility before committing to a membership.

It has no membership obligations and runs just for the month in question.

The fee grants access up to midnight on each day throughout the month.

It ends on the last day of the month that this option is availed in!
